FEDERAL RULES OF BANKRUPTCY PROCEDURE RULE 9003 **PROHIBITION OF EX PARTE CONTACTS**

Except as otherwise permitted by applicable law, any examiner, any party in interest, and any attorney, accountant or employee of a party in interest shall refrain from ex parte meetings and communications with the court concerning matters affecting a particular case or proceeding.

Contact with courtroom deputies should be for procedural matters only. Do NOT contact courtroom personnel to discuss a judge's ruling on an order, or any other matter other than procedural. If you have questions, or are in doubt about whom to contact, call the Help Desk for further assistance at 866-232-1266.

CM/ECF GENERATED HEADERS

REMINDER Some e-filers are experiencing occasional issues with PDF headers failing to display on their ECF documents. The court recommends all users print to PDF prior to uploading their documents to ECF. From your application, choose print and in the printer destination, choose Adobe PDF (or a similar print driver capable of creating a new PDF). This will create a new PDF document that will allow the headers to appear. This step should be performed regardless of whether the document is a word processing document, existing PDF, or a scanned image.
