# JUDGE BEESLEY RETIREMENT ANNOUNCEMENT

Bankruptcy Judge Bruce T. Beesley of the United States Bankruptcy Court for the District of Nevada announced his retirement effective Aug. 31, 2021.

Our Court has been very fortunate to have an incredible jurist and good friend.

Judge Beesley was appointed as a bankruptcy judge for the District of Nevada on Jan. 2, 2011, and served as chief bankruptcy judge of this court from Oct. 1, 2015 – March 31, 2020. Prior to his appointment to the bench, he was a partner and served as the bankruptcy group leader for the Lewis and Roca LLP offices in Reno, Las Vegas, Phoenix and Albuquerque, New Mexico. He was a partner at Beckley Singleton, Ltd., in Las Vegas, from 2006 to 2007, and was a shareholder and president of Beesley, Peck & Matteoni, Ltd., in Reno from 1995 to 2006.

Judge Beesley received his bachelor's degree from the University of Nevada, Reno, in 1975 and his juris doctorate from the University of the Pacific, McGeorge School of Law, where he graduated with distinction.

In the near future, Judge Beesley's cases will be reassigned to another bankruptcy judge. If there are noticing requirements due to the reassignment, the court will send notice through the Bankruptcy Noticing Center. Please contact the court's help desk with questions at (866) 232-1266.

## **INSTALLMENT PAYMENTS IN CM/ECF**

The U.S. Bankruptcy Court for the District of Nevada announces the ability for registered users of CM/ ECF to pay for Chapter 7, Chapter 11, or Chapter 13 installment payments within the CM/ECF system. The case must have an existing order **GRANTING** permission to pay filing fees in installments. Transactions will not be considered complete until the actual fee is paid and the receipt verification has been docketed.

There are two events for each chapter available for paying installments online. If you plan on paying for installments 1-3 online, you will need to use the Installment Payment 1-3 event for each payment. If you plan on paying for installment #4, you will need to use the Installment Payment 4 event.
