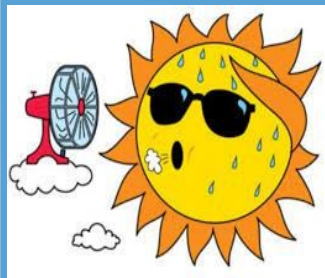

NEW COMPENSATION GUIDELINES

Effective July 1, 2022, and pursuant to Local Rule 2016, the Court is adopting [Guidelines for Applications for Compensation and Reimbursement of Expenses to Professionals](#). These Guidelines are applicable to all applications/motions for compensation and reimbursement for expenses.

All applications/motions must include the local form “Fee Application Cover Sheet” or the applications/motions will be issued a Notice Of Docketing Error (NODE). When the order is uploaded, it will not be processed if the “Fee Application Cover Sheet” is not attached to the application/motion.

HIGH COVID-19 COMMUNITY LEVEL—MASKS REQUIRED FOR FOLEY COURTHOUSE

As of June 14, 2022, Clark County has a “High” COVID-19 Community Level. Therefore, [2nd Amended General Order 2020-08](#) will go into effect for the Foley Courthouse effective June 14, 2022. Because Clark county is now **high** for positivity testing results, masks are required in public spaces . Washoe County currently has a “Medium” Community Level; however, should it become “High”, the General Order will also go into effect for the Young Courthouse.

NOTICE OF REMOTE HEARING - NEW FORM

A new local form for noticing of remote hearings is now available on the court’s website. This form, “[Notice of Remote Hearing](#)” should be used for any hearings that are held remotely, and must include the necessary information to participate telephonically.

FLATTENING ADOBE FILL-IN FORMS

Forms in Adobe should be “flattened” prior to uploading to CM/ECF. This process will make the fields on the form where you enter data permanent; anyone viewing the document will not be able to modify your information. To flatten the form, take the following steps:

1. Once you have completed inputting data on the form, click the Print button located at the bottom of the page, or select File and then Print.

2. In the Printer Name field, choose Adobe PDF and click OK or Print.
