NEW COMPENSATION GUIDELINES

<u>Effective July 1, 2022,</u> and pursuant to Local Rule 2016, the Court is adopting <u>Guidelines for Applications for Compensation and Reimbursement of Expenses to Professionals</u>. These Guidelines are applicable to all applications/motions for compensation and reimbursement for expenses.

<u>All</u> applications/motions must include the local form "<u>Fee Application Cover Sheet</u>" or the applications/motions will be issued a Notice Of Docketing Error (NODE). When the order is uploaded, it will not be processed if the "Fee Application Cover Sheet" is not attached to the application/motion.

If the cover sheet is incomplete, or the totals are incorrect, an amended cover sheet may be required before the order is processed.

AMENDMENTS TO OFFICIAL FORMS 101 AND 201 CONFORMING TO THE BANKRUPTCY THRESHOLD ADJUSTMENT AND TECHNICAL CORRECTIONS ACT.

On June 21, 2022, the Bankruptcy Threshold Adjustment and Technical Corrections Act (the "BTATC" Act) became law.

The BTATC Act once again increases the total debt threshold (as defined in the Act) for determining the eligibility of a debtor to proceed under subchapter V of chapter 11 to \$7,500,000, effective retroactively to cases commenced on or after March 27, 2020 through June 21, 2024 (two years after the date of enactment of the BTATC Act).

The following forms have been updated:

- Official Form 101, Voluntary Petition for Individuals (revises line 13
- Official Form 201, Voluntary Petition for Non-Individuals (revises line 8)
