### **LOCAL RULE 2002(c)**

LR 2002(c) delegates noticing responsibility of the First Meeting of Creditors to the debtor in chapter 9, 11, and 12 cases with more than **200** creditors and parties in interest. The debtor must give at least 21 days' notice to the trustee (if any), creditors and other parties in interest.

### **AVAILABILITY OF ONLINE PAYMENTS**

The U.S. Bankruptcy Court for the District of Nevada announces online payment options for those not registered in the CM/ECF electronic filing system. Payment of court fees (filing fees and installment payments, copies, audio recordings of hearings, etc.) may be paid online via debit card, PayPal, or ACH (electronic payment from a bank account). Credit card payments are not accepted.

NOTE: The Online Payment Form cannot be used for payments generated within CM/ECF or Chapter 13 plan payments to the trustee.

Unregistered CM/ECF users may also use this form to pay fees associated with copies of documents. Please call the ECF Help Desk at 866-232-1266 to verify the fee amount for copy requests prior to using the Online Payment form.
