Upon the application dated May 13, 2001 (the "Application")¹ of Washington Group International, Inc. ("WGI") and certain of its direct and indirect subsidiaries, debtors and debtors-in-possession in the above-captioned cases (collectively, the "Debtors"), for an order pursuant to Rule 1015(b) of the Federal Rules of Bankruptcy Procedure administratively consolidating their respective chapter 11 cases for procedural purposes only; and upon the Affidavit of Stephen G. Hanks in Support of Chapter 11 Petitions and First-Day Orders sworn to on May 13, 2001; and this Court having determined that joint administration of these chapter 11 cases is in the best interests of the Debtors, their respective estates, creditors and shareholders; and upon the record herein; and after due deliberation thereon; and good and sufficient cause appearing therefor; it is hereby

ORDERED, ADJUDGED AND DECREED THAT:

1. The Application is GRANTED.
2. The above-captioned chapter 11 cases are consolidated for procedural purposes only and shall be jointly administered by the Court.
3. The chapter 11 case of a Non-filing Affiliate, as defined in the Application, if filed on or before ^{7th}~~15~~ days

following the date of this Order, automatically shall be consolidated with the above-captioned chapter 11 cases for procedural purposes only and shall be administered jointly by the Court.

4. All relief, if any, granted by the Court in the Debtors' ~~consolidated~~ ^{jointly administered} chapter 11 cases shall be applicable to the same extent in the ~~consolidated~~ ^{jointly administered} chapter 11 cases of the Non-filing Affiliates; provided, however, that any period of time established in a prior order of the Court setting forth a deadline for the Debtors or another party in interest to act shall be calculated, solely in the Non-filing Affiliate's case, as if the order had been entered on the date the Non-filing Affiliate's voluntary petition was filed.

5. The caption of the jointly administered cases shall read as follows:


