 23 performance of those duties.


24 **IT IS HEREBY ORDERED** that the Examiner shall investigate the facts and
 25 circumstances that led to the filing by the Debtors of the Chapter 11 Cases and prepare a report
 26 setting forth the reasons for such filings. In undertaking such investigation and preparing such
 27 report, the Examiner shall be guided by the following guidelines:

1. The purpose of the report is to set forth facts and circumstances that led to the commencement of this chapter 11 case. The report shall primarily address financial and business issues.
2. The Examiner is not expected to approve or disapprove particular actions taken by the Debtors or other parties in interest nor to take sides in any disputes that are or that may be anticipated to come before this Court.
3. The Examiner's report shall not investigate or comment on the merits of the contractual dispute or other disputes between the Debtors and Raytheon.
4. There has been no allegation of fraud in these cases. Accordingly, the Examiner is not charged with commencing an investigation designed to uncover fraud. Should the Examiner find facts or circumstances indicating that fraud may have occurred, the Examiner may investigate such facts and circumstances.
5. The due date for the Examiner's report shall be August 10, 2001. The Examiner shall appear by telephone at the omnibus hearing dates on July 9, 2001 and July 24, 2001 to provide oral progress reports regarding the Examiner's report. If the Examiner believes that his report cannot be completed by August 10, 2001, he shall advise the Court at one of the above omnibus hearing dates and the Court may consider an extension of the due date.


