# WELCOME JUDGE NAKAGAWA

### MKN LV - Courtroom 2, Foley Federal Bldg MKN RN - Courtroom 2, Young Bldg

Judge Nakagawa has been assigned approximately 1/3 of the open cases in Las Vegas and all chapter 13s in Reno. Please review the **Orders Reassigning Cases** to Judge Nakagawa (MKN) posted on our website. Each order contains a list of the case numbers reassigned to Judge Nakagawa..

Remember to change the initials on the affected pleadings to **MKN**.

#### **UPCOMING CHANGES**

September and October will bring some important changes to CM/ECF as a result of BAPCPA. The Court is projecting a "go live" date of September 25, 2006 for Version 3.0. On or before October 17, 2006 Version 3.1 will be installed and ready to go. This is a reminder for e-filers to purchase any necessary updates for their petition e-filing software before these conversions.

Version 3.0 offers many changes to docketing screens, opening of bankruptcy and adversary cases, as well as changes to some reports. As we near our conversion to Version 3.1 we will be giving you more needed information.

BE AWARE: Software updates need to be in place with all e-filers who open new bankruptcy cases by the time the court goes live.

<u>Projected dates</u>: September 25, 2006 for Version 3.0 and on or before October 17, 2006 for Version 3.1.

Note: Do not install your new software BEFORE the court goes live, or the programs may not work!

# LOCAL RULE 9014 There are some updates to LR

9014 that e-filers need to conform to regarding Notices

and Certificates of Mailing. The following problems are surfacing with regularity.

**NOTICE** - missing the language required by new LR 9014(b)(1)(D)

#### **CERTIFICATE OF SERVICE**

(Corporation/Partnership) - notice by mail not sent to attention of Officer/Agent. (FRBP 7004 (b)(3))

**CERTIFICATE OF MAILING** - when applicable, omitting indication that insured depository institution was sent notice via certified mail. (FRBP 7004(h))

## **CONFIRMATION HEARINGS**

Confirmation hearings need to be set on the **last filed plan** in a case. And remember...all confirmations (in Las Vegas) are set to the 3<sup>rd</sup> floor of the Foley Federal Building.
