The matter numbers may have been modified from the last online calendar update. To use the **Court Calendar** function on the kiosk, touch anywhere on the screen to get started. **Court Calendars** allows the user to select a judge (including visiting judges) and see a list of all court hearings for that judge. You can also search for specific court hearings by party name or case number on the Search tab.

P. 1009(a), the debtor <u>must</u> send the added creditors a copy of the Notice of Chapter _____ Bankruptcy Case, Meeting of Creditors, & Deadlines . The debtor must also pay applicable fees, file a Certificate of Service in accordance with <u>LR 2002(a)(3)</u> and update the master mailing list pursuant to <u>LR 1007(b)</u>.
