## NOTICING CHAPTER 13 CONFIRMATION HEARINGS

**Administrative Order 2015-06, went into effect December 1, 2015.** The Administrative Order delegates the noticing of the chapter 13 plan confirmation hearing and the deadline to file objections to the plan to the debtor(s). The initial chapter 13 confirmation hearing dates are posted on the court's self calendaring section. The debtors are responsible for noticing of the initial chapter 13 confirmation hearing and the chapter 13 plan (which is due within 14 days of the filing of the petition) to all creditors. Failure to timely notice the chapter 13 confirmation hearing and plan may result in dismissal of the case.
