RSS FEEDS AND EMAIL UPDATES

When new content is posted to this website, you can receive updates via our RSS feeds. We offer several feeds for RSS subscription. Topics include:

You can also sign up to receive a feed of docket entries made in CM/ECF. Categories reported in the feed include: answers, appeals, orders, miscellaneous entries and trustee entries.

To utilize this feature, go to <u>https://ecf.nvb.uscourts.gov</u> and click on the **Court Information** link located in the bottom left corner of the page. When the Court Information page displays, locate the RSS Feed option and subsequently choose: **Entries made in the last 24 hours - Public Users**. A browser may be used to view the feed. Software for displaying RSS Feeds (such as Feedreader) may also be utilized. To sign up or to learn more, please visit: <u>https://www.nvb.uscourts.gov/news-rss/</u>.

The court also offers a free email subscription that allows subscribers to receive notifications by email when new information is available instead of RSS feeds. You only receive updates on topics that you specify and you may unsubscribe at any time.

NEGATIVE NOTICE vs EX-PARTE MOTIONS

Local Rule 9014.1 sets out procedures for negative notice. There are some motions, objections and other matters that may be considered by the court without a hearing under the negative notice procedure described in this Rule if no party in interest requests a hearing. Once all rule requirements have been met, and in the event no party in interest timely files an objection, the court may consider the matter without further notice or hearing upon the movant's submission of an order granting the relief. Nothing in this rule is intended to preclude the court from conducting a hearing on the motion, objection, or other matter even if no objection is filed within the time permitted in the negative notice legend.

Ex-parte Motions do not require a hearing date and time. Normally an order on an ex-parte motion is uploaded on the same day the motion is filed. If the order is granted, this usually concludes the matter. However, except for certain matters allowed to be filed ex-parte (as set out in the federal and local rules), such motions are rarely granted.

STEPS TO MANUALLY OPEN A VOLUNTARY PETITION

Official Form B101/201, known as a "Voluntary Petition" must be filed by a debtor to begin a bankruptcy case.

Note: Steps 2-7 should be done immediately after opening.

In CM/ECF, click on Bankruptcy. Then click on the following Bankruptcy Events, answering the prompts that appear.

- 1. Open Voluntary BK Case (All Chapter 13 and 11 cases are opened as ASSET cases).
- 2. Creditor Maintenance → Upload list of creditors file.
- 3. Judge/Trustee Assignment. **THIS IS A VERY IMPORTANT STEP** in opening a new petition. It is a crucial part of case opening, and will ensure that you receive your 341 notice immediately.
- 4. Miscellaneous Statement of Social Security Number(s).
- 5. Miscellaneous Declaration re: Electronic Filing.
- 6. Miscellaneous _____ select applicable Income Means Test events.
- 7. For Individuals Only: Miscellaneous Certificate of Credit Counseling.

The following applies to Chapter 13 cases only. Search for a Chapter 13 Plan Confirmation hearing (initial hearing only) date from the self-calendaring section on the court's website, https://www.nvb.uscourts.gov/calendars/self-calendaring-dates/.
