NEXT GENERATION OF CM/ECF (NEXTGEN)- IMPORTANT DATES

The U.S. Bankruptcy Court for the District of Nevada will be updating the Current CM/ECF to the Next Generation of CM/ECF (NextGen) in November 2021. By early 2022, ALL federal courts will be live on NextGen. NextGen is a filing system that is fully integrated with PACER. NextGen and PACER are linked by a module called Central Sign-On. Central Sign-On allows a user to have one ID and password to access NextGen nationwide.

Important dates:

- Monday, October 18, 2021 at 11:00 a.m. PST - Online one hour Webinar
- Friday, October 22, 2021 at 11:00 a.m. PST – Online one hour Webinar
- Friday, November 5, 2021 – all users should have upgraded their PACER accounts.
- Wednesday, November 10, 2021 at 5:00 p.m. PST, the current CM/ECF will be taken offline to back up the Court's data and begin the NextGen conversion. All docketing and new case filings must be completed before November 10, 2021 at 5:00 p.m. PST. CM/ECF is not available.
- Thursday, November 11, 2021 (Veteran's Day) – Closed for federal holiday. CM/ECF is not available.
- Friday, November 12, 2021 – Closed due to the conversion to NextGen and CM/ECF is not available.
- Monday, November 15, 2021 at 9 a.m. – NextGen will be operational for filing of documents on the official docket.

The Bankruptcy Court's CM/ECF WILL NOT be available November 10, 2021 5 p.m. PST until Monday, November 15, 2021 at 9 a.m. PST.

All fees MUST be paid in full before CM/ECF is updated to NextGen on November 10, 2021. If there are any outstanding fees, you will be locked out of your account.

FILING AGENTS—NEW LOCAL FORM FOR NEXTGEN

NextGen will require a new form, Attorney/Trustee Consent Form for Filing Agents (NVB 5005.7), to be completed by an Attorney or Trustee for any new Filing Agent requests. A "[Filing Agent](#)" is a user that can file on behalf of attorneys and trustees. This form will need to be completed prior to processing their registration in order to add the Filing Agent to ECF.
