TRANSCRIPTS

Only Court appointed transcript companies are authorized to create the official transcript of a court hearing. In 2007, the Judicial Conference approved the requirement that all transcripts are only available at the office of the Clerk of Court for inspection for a period of 90 days after it is delivered to the clerk. During this time, it is not available electronically. After the 90 days have passed, the transcript can then be made available to the general public through PACER. Authorized transcript companies are given a specific event to use in CM/ECF to meet the Judicial Conference requirements.

If an unauthorized transcript is docketed, an Order to Strike may be entered.

SUBCHAPTER V CASES

When filing a Subchapter V case, please make sure you are selecting the correct option in CM/ ECF.

Small business

A small business debtor is defined in 11 U.S.C. § 101(51D). Is this a small business debtor? Yes >

Subchapter

✓ Debtor is defined in 11 U.S.C. § 1182(1) and elects to proceed under subchapter V of Chapter 11

If a small business debtor, select yes, if you elect to proceed under Subchapter V, then check the box. If you select the incorrect choices, deadlines and hearing dates will be set incorrectly. Trustees could also be appointed. It is important that your pdf image reflects exactly what you have selected in the case opening process.

business debtor, see

11 U.S.C. § 101(51D).

If you are filing under Chapter 11, the court must know whether you are a small business debtor so that it can set appropriate deadlines. If you indicate that you are a small business debtor, you must attach your most recent balance sheet, statement of operations, cash-flow statement, and federal income tax return or if any of these documents do not exist, follow the procedure in 11 U.S.C. § 1116(1)(B).
