HEARING LOCATIONS

The U.S. Bankruptcy Court has been transitioning to hearings where parties are physically in the courtroom. Administrative Order 2020-14 temporarily imposed restrictions on in-person hearings but Administrative Order 2023-05 rescinded those restrictions. Currently, trials and hearings that require evidence will be held in the courtrooms, unless otherwise determined by the Judge presiding in each case.

The Notice of Hearings, Scheduling Orders and calendars posted on the court's website will indicate the physical location of the hearing or if hearing will be held via Zoom video or telephonically. Parties must ensure they correctly note whether or not the hearing is in person in the Notice of Hearing.

Additionally, if counsel or individuals wish to appear in person, the courtrooms are open on the days the Judges have a calendar.

SUBCHAPTER V INDIVIDUAL DISCHARGES

All individual debtors seeking discharges in cases under subchapter V of chapter 11 must complete and file the local certificate of compliance form and serve a copy of the certificate of compliance on all creditors. Failure to file this form may result in the case closing without a discharge. See [LR 3022.2](#) for more information.

TRANSCRIPT REMINDERS

When a transcript is ordered, it is the transcriber's responsibility to electronically file the transcript in CM/ECF. Do not docket the transcripts you receive via email from the transcription company.

The bankruptcy court does not have records of the 341 Meeting of Creditor proceedings. For chapter 7 and 11 cases, you must contact the Office of the United States Trustee. For chapter 13 cases, please contact the trustee to whom the case is assigned. This information can be found on the docket.
