HON. NATALIE M. COX WILL BECOME CHIEF BANKRUPTCY JUDGE EFFECTIVE APRIL 1, 2025

After completing a five-year term, Hon. August B. Landis will step down as Chief Bankruptcy Judge in the District of Nevada on March 31, 2025. Effective April 1, 2025, Hon. Natalie M. Cox will begin her term as Chief Judge.

Judge Cox was appointed to the bankruptcy bench by the U.S. Court of Appeals for the Ninth Circuit on January 27, 2020. Her oath of office was administered by our friend and colleague Hon. Bruce T. Beesley (Ret.).

Originally from Kodiak, Alaska, our incoming Chief attended Austin Peay State University in Clarksville, Tennessee. While in college, Judge Cox's leadership skills were already on full display as she played point guard for the first Lady Governors team to appear in the NCAA tournament, as well as catcher and 3rd base on the Lady Gov's softball team. She graduated with a bachelor's degree, summa cum laude, in 1997. She attended law school as part of the charter class at the William S. Boyd School of Law at the University of Nevada Las Vegas, receiving her juris doctorate degree, cum laude, in 2001. After successful completion of the Nevada bar exam in October 2001, Judge Cox engaged in the private practice of law with Jolley, Urga, Wirth & Woodbury, and Kolesar & Leatham, Chtd.

Prior to taking the bankruptcy bench, Judge Cox also served as a trial attorney with the U.S. Trustee's field office in Wilmington, Delaware and Nashville, Tennessee. In April 2019, she was promoted to the position of Assistant U.S. Trustee in Nashville and served in that capacity until returning to Nevada with her family to take her seat on the bankruptcy bench in Las Vegas.

During her five years of service as a bankruptcy judge in Nevada, Judge Cox has displayed her ability to efficiently handle cases and issues of every size and type. She looks forward to her new role as Chief Judge and has the full support of the entire bankruptcy court family as she begins her new endeavor. CHAPTER 13 CALENDAR CHANGES, RENO AND LAS VEGAS

A review of the work being performed by the Clerk's staff is done on a regular basis to see what processes can be streamlined or automated. A review of the chapter 13 calendars shows that some matters are being continued 10 - 20 times.

Due to current staffing authorized for the Clerk, managing the chapter 13 calendars under the current process is not sustainable. To ensure Clerk's staff can perform their statutory duties, the bankruptcy judges agreed to make changes to the management of the chapter 13 calendars.

Effective April 1, 2025, matters on the Chapter 13 calendar regarding confirmation, motions to modify and motions to dismiss <u>will be restricted to one continuance</u>. The matter will come off calendar if it is not resolved after the first continuance. Once a matter is taken off calendar, a new notice of hearing and noticing of the parties will be required when it is ready for a bankruptcy judge to make a final ruling.

The chapter 13 trustees were updated in February of the changes to the chapter 13 calendars. The bankruptcy judges and clerk of court are aware that this is a significant cultural change for the management of the chapter 13 calendars. There will be issues, and the bankruptcy judges will make decisions accordingly.
