## **SELF-CALENDARING DATES**

The self-calendaring system allows both counsel and parties to schedule hearing dates for most matters heard on regular notice without having to contact the court to obtain a hearing date.

The following matters are available for self-calendaring:

- Avoid Lien
- Chapter 13 Application for Compensation
- Chapter 13 Objection to Claims
- Chapter 13 Plan Confirmation
- Loan Modification
- Relief from Automatic Stay
- Value Collateral

Note: Any motions relating to an involuntary case should not use the self-calendaring system, instead <u>click</u> here to Request a Hearing Date for other types of hearings.

To find details about your case, such as the judge or chapter, log into <u>PACER</u>.

#### Search for Available Date and Time

You may search for a hearing date based on the judge assigned to the case, chapter and matter type. Upon selection of an available date and time, counsel should serve proper notice of the matter in accordance with Federal Rules of Bankruptcy Procedure and Local Rules.

Verify that you are selecting the correct location for the case, for example case numbers that begin with 1 are for Las Vegas and 5 for Reno, with the exception of some cases assigned pursuant to Local Rule 1015.

## SUBSTITUTION OF ATTORNEY

Pursuant to <u>Local Rule 2014(b)</u>, a stipulation and order permitting substitution of attorney may be submitted ex parte if:

- (1) the substitution is signed by the client, the withdrawing attorney and the substituting attorney; and
- (2) the substituting attorney acknowledges responsibility for all pending dates and deadlines. Notwithstanding this provision, the court may require that requests for substitution of attorney be set on noticed hearing. In the event that the withdrawing attorney is disbarred, suspended, or no longer in good standing to represent the client, such attorney's signature is not required for the substitution
