DOCKETING ORDERS SHORTENING TIME

The following steps apply only to Orders Shortening Time (OST) and NOT to Ex Parte Orders:

1. Docket: Motion to be heard on OST. **Bankruptcy** > Motions/

Applications or Adversary > Motions

Select: Motion for Order Shortening Time (refer to the original

motion). Select Bankruptcy > Motions/Applications > Order

Shortening Time OR

Adversary > Motions > Order Shortening Time (Adv)

2. Docket: Declaration/Attorney Information Sheet (refer to Motion to

Shorten Time). Select **Bankruptcy** or **Adversary** > Miscellaneous > Declaration/Attorney Information Sheet

3. Upload: Order to Shorten Time.

Choose: Bankruptcy or Adversary > E-Orders > Order Upload >

Single Order Upload

Enter: Case Number > Click Next

Enter: Related document number (refer to Motion to Shorten

Time) > Click Next

Select: Order Type > Order Shortening Time

(NOTE: DO NOT SELECT EX-PARTE ORDER!)

Hearing Date > (LEAVE BLANK) > Click Next

Browse and attach the PDF image of Order

After the order has been signed, you will receive an electronic notification from the court with the hearing date and time. The next step is to file a Notice of Hearing (refer this to the original motion), and a Certificate of Service (refer to the documents being served).



CM/ECF EVENTS

It is important to use the correct event in CM/ECF. For example, if your document is an Objection, please do not use the "Response" event. Instead, select the "Objection" event. Using the correct event ensures the item appears on the docket correctly, and it helps the court manage the case by setting a hearing; setting or terminating a deadline or case flag; and linking correctly to a response, objection or notice. To find the correct event, use the **Search** option on the blue menu bar. If you use the wrong event, you may receive a Notice of Docketing Error (NODE).

PROPOSED FEDERAL RULE AMENDMENTS PUBLISHED FOR PUBLIC COMMENT

On June 10, 2025, the Judicial Conference Committee on Rules of Practice and Procedure (Standing Committee) approved publication of proposed amendments to the following:

- Appellate Rule 15;
- Bankruptcy Rule 2002, Official Forms 101 and 106C;
- Civil Rules 7.1, 26, 41, 45, and 81;
- Criminal Rule 17; and
- Evidence Rule 609 and new Rule 707.

Written comments are welcome on each proposed amendment. The advisory committees will review all timely comments, which are made part of the official record and are available to the public. **The comment period closes on February 16, 2026**.

Comments must be submitted electronically using the regulations gov portal. Follow the online instructions for submitting or reviewing comments at regulations gov under the general FAQs section.

PACER-SECURITY ENHANCEMENTS UPDATE

The PACER Service Center (PSC) is currently experiencing long call wait times due to the implementation of several security enhancement features for PACER accounts, including updated password standards and multifactor authentication (MFA).

To help mitigate the wait times, enforcement of the updated password standards has been temporarily delayed. In addition, PSC asks that only users who receive a prompt to enroll in MFA when they log in should do so. If you do not receive an MFA enrollment prompt, no action is necessary. Please do not contact the PSC with questions about MFA until you are required to enroll. This ensures support is available for those who need it. Frequently asked questions are addressed in the MFA Tips and Resources list, which should be reviewed before contacting the PSC.
