# NEW CM/ECF EVENTS FOR RULE 3002.1 OFFICIAL FORMS

On December 1, 2025, amendments to Rule 3002.1 of the Federal Rules of Bankruptcy Procedure added several new provisions. The process of verifying and objecting to post-petition default status requires the use of new official <u>forms</u>. Details on the forms can be found <u>here</u>. The Court has created new docket events to align the Case Management/Electronic Case Filing System (CM/ECF) with the new forms, as shown in the chart below.

# FUNDS AVAILABLE FOR CHAPTER 7 TRUSTEE PAYMENTS FOR FY 2024 CASES

The Department of Justice has <u>announced</u> that there are sufficient funds available for transfer under 11 U.S.C. § 589a(f)(1) to pay chapter 7 trustee compensation under 11 U.S.C. § 330(e) in applicable fiscal year (FY) 2024 cases. In accordance with 11 U.S.C. § 330(e)(4) and the judiciary's regulations governing section 330(e) compensation, the amount for payment in applicable FY 2024 cases is \$60. The Court anticipates that funds will be transferred and available for disbursement in early 2026.
