4 If you do not file a written response with the court, or if you do not serve your  
5 written response on the person who sent you this notice then:

- 6 • The court may *refuse to allow you to speak* at the scheduled  
7 hearing; and
- 8 • The court may *rule against you* without formally calling the  
9 matter at the hearing.
