ORDER OF SUSPENSION

On December 16, 2020, this Court entered an Order to Show Cause (“OSC”), mailed via certified mail with a Certified Mail Return Receipt. However, the Order to Show Cause was returned from the United States Postal Service marked “Return to sender- Attempted- Not Known-Unable to forward.” Regardless, the OSC provided Mr. Vargas with 30 days to respond with reasons why he should not be suspended from the practice of law in this Court. (ECF No. 1.) No response has been received from Mr. Vargas. Failure to respond within thirty 30 days warrants an Order of Suspension. See LR IA 11-7.
