ADMINISTRATIVE ORDER 2021-09

11 In response to the coronavirus disease 2019 ("COVID-19") pandemic in the District of
12 Nevada and nationally, the Court previously issued a series of Administrative Orders. Those
13 orders were temporary in nature. They were issued in an effort to contain the spread of
14 COVID-19 in Nevada through actions consistent with federal and state guidance, while still
15 affording the public access to justice through the Court.

16 Since the COVID-19 Administrative Orders were issued, the Court has continued to
17 closely monitor available official information regarding the COVID-19 pandemic. The Court
18 also remains committed to continuing its service to the public during the COVID-19 outbreak,
19 while taking prudent action to protect Court employees and all stakeholders in the bankruptcy
20 process from transmission of the COVID-19 virus.

22 The Court is mindful that Governor Sisolak announced Nevada's plan to return to 100
23 percent capacity and issued Directive 044 outlining that goal, effective June 1, 2021. The Court
24 has revisited the COVID-19 Administrative Orders in order to ensure that Court operations are
25 carried out in a way that is consistent with the goals of Directive 044 while minimizing the
26 potential for transmission of COVID-19.

1 **IT IS THEREFORE ORDERED that Administrative Order 2020-08 is**
2 **RESCINDED effective JUNE 1, 2021. All other Administrative Orders remain in effect**
3 **absent further Court order.**
4

5 **IT IS FURTHER ORDERED** that the Intake offices at both the Reno and Las Vegas
6 Bankruptcy Court will reopen to the public on June 1, 2021. The Court's normal operating
7 hours are from 9:00 a.m. to 4:00 p.m., Monday through Friday, except federal holidays.
8

9 **IT IS FURTHER ORDERED** courtesy copies are required in accordance with the
